The State Level Committee constituted as per provisions of Rule 10 of West Bengal Right of Children to free & Compulsory Education Rules, 2012 in its meeting dated- 26/12/2018 had approved the proposal of issuance of 'No Objection Certificate'/Certificate of Recognition and hence the School Education Directorate hereby issues 'Permanent No Objection Certificate'/Certificate of Recognition for class I (One) to class VIII(Eight) in respect of **Don Bosco School**, as an unaided school, for the purpose of preparing its candidates to appear in the final examination of the Central Board of Secondary Education and subject to observance of the following terms and conditions all the time failing which the 'Permanent No Objection Certificate'/Certificate of Recognition, issued in favour of the school may be withdrawn.

1. That the school authority shall maintain and fulfil all the conditions all the time as mentioned in Rule 10(15) of the WBRTE Rules, 2012.
2. That the school authority shall never claim any financial assistance from State Govt.
3. That the school shall be located in a relatively noise free and pollution free area having adequate supply of drinking water and electricity.
4. That the school shall have classroom of adequate space commensurate with the enrolment which is comfortable and suitable for imparting lesson and not less than the number of class units.
5. That the school have a playground for the students and a barrier free access.
6. (a) That the school shall have separate toilet for the boys and girls in case of co-ed school)and teachers.
6. (b) That the school shall have girls' common room, if it is a girls' or co-ed school, teachers room and adequate furniture.
7. That the school shall have sufficient fire safety equipments and have trained person/s among the staff to operate those equipments.

25. That the school authority shall ensure that there shall not be any activity in the school which may create acrimonious feelings or division among students on the basis of caste, creed, race or religion.
